The privilege of speaking at this time is limited to the following persons: residents, persons having an ownership interest in property or a business located within the City, or their attorneys.

A statement of no more than 3 minutes may be made on items of general relevance. There will be no yielding of time to another person. State law prohibits the Mayor and members of the City Council from commenting on any statement or engaging in dialogue without an appropriate agenda item being posted in accordance with the Texas Open Meetings Law. Comments should be directed to the entire Council, not individual members. Engaging in verbal attacks or comments intended to insult, abuse, malign, or slander any individual shall be cause for termination of time privileges and removal from Council Chambers.

 - A. Consider and take action on authorizing the City Manager to bid and acquire additional playground equipment at David Braun Park.

- B. Consider and take action to authorize the City Manager to sign a contract extension with Crowder Gulf as the primary contractor for disaster debris removal and Ceres Environmental as the secondary debris removal contractor
- C. Consider and take action to authorize the City Manager to sign a contract extension with True North Emergency Management as the primary contractor for disaster debris monitoring services.
